Message from the Management Team

Committees are at the heart of the Senate's legislative and policy review work and Canadians contribute to that work every year by appearing as witnesses or by providing written testimony. Canadians can also follow the work of committees by watching webcasts or CPAC broadcasts, or by reading transcripts, briefs and reports on a committee's website. Senators spend an enormous amount of time engaged in committee work. The Committees Directorate serves Senate committees in the areas of parliamentary procedure and practice, logistics and administration, and provides advice and resources to help committees to achieve their objectives.

This past year has been marked by a return to regular activity levels, with committees resuming full operations with no major interruptions in the parliamentary calendar, coupled with the ability to meet regularly according to the pre-pandemic committee schedule. Committees also resumed regular travel activities, with eight fact-finding missions and public hearings outside of Ottawa that were successfully completed. Committees met and reported on a range of topics such as housing, the foreign service, the impact of Islamophobia, Arctic security, suicide prevention, inflation, truth and reconciliation, anti-black racism and examined the structure and mandates of Senate committees, among countless other issues that matter to Canadians.

Building on the success of virtual technology, Senate committees again heard from over 2000 witnesses during the year. This past year, the Committees Directorate team worked in close collaboration with colleagues from other directorates and partners on Parliament Hill to successfully implement the use of mandatory headsets and advance technical testing for all videoconference participants to ensure safer proceedings. This new process has streamlined the identification and resolution of technical issues in advance of appearances, which resulted in a significant reduction in disruptions, and has led to more efficient and uninterrupted meetings.

The Committees Directorate takes great pride in providing senators with professional, non-partisan procedural, logistical and administrative support. Once again, our team consistently demonstrated their resilience and ability to adapt in an evolving work environment. Building the knowledge and capacity of our team remains a priority, as the coming year will bring important changes to the Directorate's leadership. Through this period of transition, we have full confidence that our team's focus remains on steadfastly supporting the vital work of senators and to promote the significant contributions of Senate Committees to all Canadians.

Part 1: Overview of Activities and Expenditures

Structure of Committees

The Committees Directorate provides administrative, procedural and informational support to Senate committees, which included the following committees during the 2023-24 fiscal year:

- Eighteen standing committees (and six subcommittees); and
- Two standing joint committees and two special joint committees (composed of members from both the Senate and the House of Commons).

The size of committees, their general areas of study and the number of members required for quorum are set under rules 12-3, 12-6 and 12-7 of the *Rules of the Senate*.

Overview of Committee Activities

Committees account for much of the important work of the Senate. While all committees must respect the *Rules of the Senate* and the *Senate Administrative Rules* (SARs), there are variations between committees with respect to how they undertake, organize and carry out their work. Some committees focus almost exclusively on legislation, while others give special studies most of their attention.

Committee activity continued at a steady pace during the 2023-24 fiscal year, as evidenced by the statistics presented later in this report. Joint committees were also active during the 2023-24 fiscal year. In October 2023, the Senate authorised joint committees to continue holding hybrid meetings, thereby extending an order which had expired at the end of June 2023.

In addition, committees undertook a significant amount of travel during the 2023-24 fiscal year. Eight committee trips were completed over the course of the fiscal year to various destinations within Canada and abroad.

Contributions to Public Policy Development: Special Study Reports

The following list highlights special study reports that were completed during the fiscal year.

Foreign Affairs and International Trade (AEFA)

Strengthening Canada's Autonomous Sanctions Architecture: Five-Year Legislative Review of the Sergei Magnitsky Law and the Special Economic Measures Act (<u>Tenth Report</u> [Interim] – tabled on May 16, 2023)

This study examined the provisions and operation of Canada's two core pieces of autonomous sanctions legislation: the *Justice for Victims of Corrupt Foreign Officials Act (Sergei Magnitsky Law)* and the *Special Economic Measures Act*. The committee's study was an opportunity to examine the effectiveness and functioning of these two Acts, particularly in the context of geopolitical challenges. The study began months after Russia's full-scale invasion of Ukraine in February 2022, during a period in which the use of autonomous sanctions had become a preferred diplomatic course of action by Canada and many of its allies in response to the war in Ukraine and other international crises.

The committee's study found that Canada would benefit from better tools to assess the impact and effectiveness of its sanctions, including unintended consequences. Among its 19 recommendations, the committee called on the Government of Canada to provide the public and private sector with written guidance on the interpretation of Canada's sanctions laws and regulations. The committee also recommended that the Government of Canada work with its allies to establish a formal mechanism for the coordination and implementation of autonomous sanctions and for the sharing of best practices on how to maximize sanctions effectiveness.

More than a Vocation: Canada's Need for a 21st Century Foreign Service (<u>Twelfth Report</u> [Interim] – tabled on December 6, 2023)

The first substantive examination of the Canadian foreign service in more than 40 years, this study examined whether the Canadian foreign service remained fit for purpose. The committee's study took place at a time when the Government of Canada and many of Canada's allies were in the process of performing diplomatic modernization exercises. Overall, the committee's study found that the Government

of Canada needs to reinvest in Canadian diplomacy to ensure that Global Affairs Canada (GAC) and the Canadian foreign service are prepared to meet the complex global challenges of the decades to come.

Drawing on witness testimony and lessons learned during fact-finding missions to the United States, the United Kingdom, Germany and Norway, this report offers 29 recommendations for modernizing Canadian diplomacy. The committee's recommendations span areas that include organizational structure and coherence, recruitment, career management, and conditions of foreign service. For example, the committee recommended that GAC run an annual entry-level foreign service officer recruitment campaign to fill all foreign service vacancies and better enable the deployment of surge resources in emergency situations. As well, it recommended that GAC establish a pathway in the Canadian foreign service for specialists who would be expected to maintain, with the support of relevant training, specific geographic, functional and/or linguistic expertise and competencies over the course of their career.

Indigenous Peoples (APPA)

Voices of Youth Indigenous Leaders 2023: Celebrating Leadership in Indigenous Education

(Sixteenth Report [Interim] – tabled on November 15, 2023)

On June 7, 2023, the committee held their annual event entitled Voices of Youth Indigenous Leaders (formally known as Youth Indigenize the Senate), which has been taking place annually since 2016.

The committee invited eight Indigenous youth leaders from across the country to discuss their perspectives on Indigenous education, including participants' experiences and challenges within various education systems and their vision for the future of Indigenous education. The committee's report summarized the testimony. The report also referenced submissions the committee received from Indigenous youth as part of the application process for Voices of Youth Indigenous Leaders. A brief comprising all these written submissions was published on the committee's website.

Honouring the Children Who Never Came Home: Truth, Education and Reconciliation

(Fourteenth Report [Interim] – tabled on July 19, 2023)

On March 21, 2023, the committee held a meeting on the work of the National Centre for Truth and Reconciliation (NCTR) and the Office of the Independent Special Interlocutor for Missing Children and Unmarked Graves and Burial Sites associated with Indian Residential Schools.

The interim report provides an overview of this meeting and highlights the testimony from Independent Special Interlocutor Kimberly Murray, NCTR Executive Director Stephanie Scott, and Indian Residential School Survivor and Elder Barbara Cameron. The report includes a table produced by the NCTR summarizing a list of records that are outstanding by various entities and organizations. In the report, the committee committed to holding additional hearings with entities and organizations that have not released the records that were included in this list. The report also made additional recommendations which focused on supporting residential school survivors, families and communities.

On the Outside Looking In: The Implementation of the *Cannabis Act* and its effects on Indigenous Peoples

(<u>Twelfth Report</u> [Interim] – tabled on June 14, 2023)

In fall 2022, the committee studied the implementation of the *Cannabis Act* and how the legalization of cannabis has affected Indigenous peoples. The committee's report is intended to inform the work of the Expert Panel from Health Canada that is tasked with assessing the implementation of the *Cannabis Act* and highlights the problems identified by First Nations prior to the legalization of cannabis and its subsequent implementation.

Banking, Commerce and the Economy (BANC)

Needed: An Innovation Strategy for the Data-Driven Economy (Eighth Report [Interim] – tabled on June 15, 2023)

On March 8, 2023, the committee resumed its study on business investment after releasing an interim report on June 20, 2022. This time, the committee focused its

study more narrowly on business investment in the disproportionally fast growing digitally intensive sector, including those businesses that rely heavily on intellectual property (IP) and data. Over the course of eight meetings, the committee heard from a variety of witnesses across different sectors and received written briefs. In its report, the committee called for an urgent update in the federal government's policies related to incentivizing and retaining commercial value of businesses in Canada. In its report, the committee concludes that to stimulate business investment, it is imperative to adopt policies that foster a coordinated and targeted whole-of-system approach towards the generation and preservation of intangible economic value in Canada and explore five different approaches that could facilitate this approach.

Study on Housing Affordability - Interim Findings

(Eleventh Report [Interim] – tabled on December 5, 2023)

On October 5, 2023, the committee resumed its study on Housing Affordability in Canada and held seven meetings to hear recommendations from a variety of witnesses. Some of these witnesses included the Governor of the Bank of Canada, the Canada Mortgage and Housing Corporation, the Office of the Superintendent of Financial Institutions, Credit Unions, the Canadian Bankers Association, financial experts, and the Minister of Housing, Infrastructure and Communities, Infrastructure Canada. The committee found that the recommendations from witnesses to increase housing supply in Canada fell under four themes: alignment, innovation, people and capital. In its report, the committee asked that the federal government consider these themes when preparing its upcoming budget.

Energy, the Environment and Natural Resources (ENEV)

HYDROGEN: A Viable Option for a Net-Zero Canada in 2050? (Fourth Report [Interim] – tabled on May 9, 2023)

In March 2022, the Standing Senate Committee on Energy, the Environment and Natural Resources launched its study on hydrogen's potential role in the energy transition for Canada to achieve its goal of net-zero greenhouse gas emissions by 2050 (NZE2050), under its general order of reference. The study examined how Canada's goal in achieving NZE2050 would depend, in part, on low-carbon intensity (CI) electricity and low-CI fuels, including hydrogen. The committee held nine meetings on this topic, hearing from 33 witnesses. The report concludes with fourteen recommendations seeking to improve and make transparent Canadian energy models and related methodologies, while investing in hydrogen hubs that will help achieve NZE2050 and focus on growing the domestic low-carbon intensity hydrogen supply and demand for critical sectors. Following its adoption, the Senate will request that the Government of Canada table a comprehensive response to this report.

Legal and Constitutional Affairs (LCJC)

Self-induced Extreme Intoxication and Section 33.1 of the Criminal Code (<u>Twelfth report</u> [Final] tabled on April 27, 2023)

On June 23, 2022, the committee began a special study on various issues pertaining to how section 33.1 of the *Criminal Code* applies in rare circumstances when a person commits the act of a violent crime while in state of self-induced extreme intoxication that is akin to automatism. Over the course of this fiscal year, the committee conducted a series of meetings and heard from 15 witnesses on the topic. On April 27, 2023, the committee reported its findings to the Senate, making six recommendations to the Government. The Government's response was subsequently tabled in the Senate on August 24, 2023.

Human Rights (RIDR)

Combatting Hate: Islamophobia and its impact on Muslims in Canada (<u>Sixth report</u> [Interim] deposited with the Clerk of the Senate on November 2, 2023)

The committee began its study on Islamophobia in June 2022. In total, 138 witnesses testified before the committee; many others spoke to senators informally during the committee's fact-finding mission in communities across Canada. The report outlines the committee's findings from its year-long study into the sources of Islamophobia in Canada, incidents of discrimination, physical violence and online hate against Muslims, and the effects of these events on individuals and communities. The report concludes with 13 recommendations to address the disturbing rise of Islamophobia in recent years and, following its adoption, the Senate requested that the Government of Canada respond without delay.

Anti-Black Racism, Sexism and Systemic Discrimination in the Canadian Human Rights Commission

(<u>Seventh report</u> [Interim] deposited with the Clerk of the Senate on December 11, 2023)

The committee began its study in May 2023. It heard from 24 witnesses and received many written briefs. The committee's study was prompted by a set of grievances filed against the independent Canadian Human Rights Commission (CHRC) about its treatment of Black and racialized employees, which raised serious concerns about its decision-making processes when dealing with human rights complaints. Testimony, as well as written submissions to the committee, demonstrated a crisis of confidence in the federal human rights system and underscored that no institution is immune from systemic racism. The report makes 11 recommendations to immediately address the problems at the CHRC and to meaningfully confront the broader issue of systemic racism across the federal public service. Following its adoption, the Senate requested that the Government of Canada respond without delay.

National Security, Defence and Veterans Affairs (SECD)

Arctic Security Under Threat: Urgent needs in a changing geopolitical and environmental landscape

(Sixth report [Final] deposited with the Clerk of the Senate on June 28, 2023)

On March 21, 2022, the Standing Senate Committee on National Security, Defence and Veterans Affairs began a study on Security and Defence in the Arctic, including Canada's military infrastructure and security capabilities. The committee held 13 meetings on the topic, hearing testimony from 68 witnesses, including the Minister of National Defence and officials from various departments, in addition to Indigenous leaders, academics, and experts on Arctic Governance and Defence Policy. The report makes 23 recommendations calling for the inclusion of Arctic security in the next defence policy, ongoing collaboration with Arctic Indigenous governments and treaty rights holders, and other Arctic nations, addressing issues with recruitment and retention of Canadian Rangers, and the improvement of Coast Guard and Defence infrastructure. The Time is Now: Granting equitable access to psychedelic-assisted therapies (<u>Seventh report</u> [Interim] deposited with the Clerk of the Senate on November 8, 2023)

On April 27, 2022, the Subcommittee on Veterans Affairs began a study on Emerging treatments for Canadian Armed Forces and Royal Canadian Mounted Police Veterans suffering from occupational stress injuries. The committee held 11 meetings on the topic, hearing testimony from 23 witnesses, including officials from Veterans Affairs Canada and the Canadian Armed Forces, in addition to academics, experts from the medical community, and advocates for psychedelic research. The report recommends that the government launch and fund a large-scale research program on psychedelic-assisted psychotherapy for treating those mental disorders and other conditions that have been identified as potential targets for these therapies.

Social Affairs, Science and Technology (SOCI)

Doing What Works: Rethinking the Federal Framework for Suicide Prevention (<u>Fifteenth report</u> [Final] deposited with the Clerk of the Senate on June 8, 2023)

On February 9, 2023, the Standing Senate Committee on Social Affairs, Science and Technology began a study on the Federal Framework for Suicide prevention. The committee held nine meetings on the topic, hearing testimony from 23 witnesses, including the Minister of Mental Health and Addictions, as well as academics and expert advocates from organizations advocating for mental health. The report makes 11 recommendations to update the Federal Framework for Suicide Prevention, prioritizing the promotion of evidence-based interventions, data collection, and acknowledging the crisis of Indigenous overrepresentation in Canada's suicide rate.

Medical Assistance in Dying (AMAD)

MAID and Mental Disorders: the Road Ahead


(<u>Third report</u> [Final] deposited with the Clerk of the Senate on January 29, 2024)

The committee was tasked with reviewing the state of the field in Canada and evaluating the degree of preparedness attained for a safe and adequate application of MAID in cases where a mental disorder was the sole underlying medical condition (MAID MD SUMC) in advance of the eligibility of MAID MD SUMC coming into force on March 17, 2024. The witnesses that appeared before this special joint committee expressed a range of opinions on the topic. The committee heard that governments, regulators, and practitioners had taken significant action to prepare for MAID MD SUMC eligibility, and that work was ongoing. At the same time, many witnesses remained preoccupied by the challenges of assessing irremediability, distinguishing requests for MAID from suicidality, and protecting the most vulnerable members of society. While some witnesses felt that Canada was ready, others felt that it was not adequately prepared, and some felt that readiness will never be attained.

The report ultimately recommended that, at this time, Canada's medical system was not prepared for MAID MD SUMC, and that the practice should not be made available until the federal Health and Justice ministers conclude, in consultation with their provincial and territorial counterparts and with Indigenous Peoples, that its safe and adequate provision is possible. The report also recommended that the committee be re-established one year in advance of the law permitting MAID MD SUMC coming into force to study the question again.

The committee's final report was tabled a few days before Bill C-62 was introduced in the House of Commons. The bill received royal assent on February 29, and had the effect of extending the date at which MAID MD SUMC would become eligible by three years, to March 17, 2027.

Standing Committee on Foreign Affairs and International Trade (AEFA)

General Information

The Standing Senate Committee on Foreign Affairs and International Trade has the mandate to examine legislation and matters relating to foreign and Commonwealth relations, including treaties and international agreements, external trade, foreign aid and territorial and offshore matters.

During the fiscal year, the committee studied and reported back to the Senate on the subject matter of certain elements contained in Divisions 4, 5, 10 and 11 of Part 4, and in Subdivision A of Division 3 of Part 4 of Bill C-47. The committee also studied and reported back to the Senate on Bill C-57.

Over the course of the fiscal year, the committee completed its comprehensive review of the provisions and operation of the *Justice for Victims of Corrupt Foreign Officials Act* (Sergei Magnitsky Law) and the *Special Economic Measures Act*, pursuant to section 16 of the *Justice for Victims of Corrupt Foreign Officials Act* (Sergei Magnitsky Law). It also completed its study on the Canadian foreign *service and elements of the foreign policy machinery within Global Affairs Canada. In October 2023, the committee began a study on Canada's interests and engagements in Africa.*

The committee also undertook one fact-finding mission during the fiscal year: to London (United Kingdom), Oslo (Norway) and Berlin (Germany) in September 2023.

During this fiscal year, the committee studied and reported back to the Senate on Bill S-236 and Bill C-234. The committee continued to hold meetings on its study on the status of soil health in Canada and on the government response to the committee's report entitled *Treading Water: The impact of and response to the 2021 British Columbia floods*.

The committee also undertook three fact-finding missions during the fiscal year as part of their study on soil health: a visit to Guelph, Ontario in April 2023; a visit to Rome, Italy in July 2023 to attend the Global Soil Partnership Plenary Assembly, Food and Agriculture Organization of the United Nations; and a visit to Saskatoon, Saskatchewan and Calgary, Alberta in August 2023.

Standing Committee on Audit and Oversight (AOVS)

General Information

The Standing Committee on Audit and Oversight was created on October 1, 2020, based on the principles of integrity, independence, transparency, and accountability. These principles are essential to fulfilling the committee's mandate to provide oversight and report on the Senate's spending. The committee is authorized, on its own initiative, to exercise the review, monitoring and inquiry function of the Senate's financial operations. More specifically, it is responsible for: retaining the services of and overseeing the external and internal auditors; supervising the Senate's internal and external audits; reviewing the Senate's quarterly financial reports and the audited financial statements for information purposes; and tabling before the Senate all relevant financial documents, including an annual report with observations and recommendations. It is also tasked with reviewing the Senate Administration's action plans to ensure that they adequately address the recommendations and findings that may arise from internal and external audits and that they are effectively implemented.

Throughout the year, the committee worked on selecting a Chief Audit Executive to lead a new internal audit function while also examining practices and lessons learned from other legislatures. During the summer recess in July 2023, the committee conducted a fact-finding mission to London, United Kingdom, where they met with counterparts from both the House of Lords and the House of Commons. This study provided valuable insights on how to enhance oversight on key matters and support the transition to a new internal audit function. The committee's findings are detailed in its Tenth Report to the Senate.

The committee completed its search and appointed a Chief Audit Executive in October 2023. Following a successful onboarding process, aided by the committee's guidance and contributions from Senate Administration management, the committee shifted its focus to the Senate's governance, risk management and control arrangements.

Every year, in June, the committee releases an annual report. This report summarizes the work of the committee for the previous fiscal year and includes observations from committee members on key audit and oversight issues identified over the fiscal year. In 2023-24, the committee presented a total of four reports to the Senate.

During the fiscal year, the committee studied the subject matter of Bill C-41 and completed two special studies tabled in fall 2023: *Combatting Hate: Islamophobia and its impact on Muslims in Canada* (interim) and *Anti-Black Racism, Sexism and Systemic Discrimination in the Canadian Human Rights Commission* (interim). For each report, a government response was requested and provided in Spring 2024.

Under its general order of reference, the committee also began its study on Forced Global Displacement in October 2023. RIDR heard from experts and stakeholders on a wide range of issues, including the effects of displacement on children, the efficacy of the *Global Compact on Refugees*, new and emerging mechanisms for financial support, the role of private sponsorship, the impacts of climate change, and Canada's international role in curbing forced displacement while supporting refugees.

For its first public hearings of 2024, the committee studied the government response to its *Human Rights of Federally-Sentenced Persons* report. This report was tabled on June 16, 2021, during the Second Session of the Forty-third Parliament, following an in-depth study launched in early 2017, which spanned three different parliaments. The report was followed by a motion asking for a government response on June 23, 2021. Then came the Canadian federal election on September 20, 2021. The committee's motion asking for a government response was renewed on May 9, 2023, and the response was received from the Minister of Public Safety on October 4 of the same year.

Special Joint Committee on Medical Assistance in Dying (AMAD)

In April 2021 and again in March 2022, the House of Commons and Senate established the Special Joint Committee on Medical Assistance in Dying and tasked it with the statutory review of the provisions of the *Criminal Code* relating to medical assistance in dying (MAID) and their application. The committee's second report was tabled in February 2023.

The committee was re-established in October 2023, in accordance with that report's 13th recommendation, to verify the degree to which the country was prepared for the coming into force, scheduled for March 17, 2024, of MAID eligibility for those whose sole underlying medical condition was a mental disorder. The committee's final report was submitted to both Chambers on January 29, after which the committee expired again.

Special Joint Committee on the Declaration of Emergency (DEDC)

General Information

On February 14, 2022, in response to the ongoing blockades and protests taking place in Ottawa and at some border crossings, the Prime Minister announced that the Governor in Council had invoked the *Emergencies Act* for the first time since its adoption, issuing a declaration of a public order emergency and giving the federal government certain temporary powers.

The *Emergencies Act* sets out the procedure by which a national emergency can be declared and by which a declaration of emergency can be confirmed, continued, amended and revoked. It also provides for a supervisory role for Parliament.

Under subsection 62(1) of the *Emergencies Act*, a parliamentary review committee must review the "exercise of powers and the performance of duties and functions pursuant to a declaration of emergency." Accordingly, this special joint committee was established by the Senate and House of Commons on March 3, 2022.

The declaration of emergency was revoked on February 23, 2022 by proclamation. Under section 62(6)(c) of the *Emergencies Act*, the parliamentary review committee is obligated to report to Parliament within seven sittings days after the revocation of the declaration of emergency. As such, the committee presented its first report in March 2022. The committee then continued to hear from witnesses until February 2024.

The committee's work coincided with the Public Order Emergency Commission (also known as the Rouleau Commission), pursuant to section 63(1) of the *Emergencies Act*. The Rouleau Commission released its final *Report of the Public Inquiry into the 2022 Public Order Emergency* on February 17, 2023.

General Information

The mandate of the Standing Joint Committee for the Scrutiny of Regulations is defined by the *Statutory Instruments Act*, which authorizes it to review and scrutinize certain statutory instruments made after December 31, 1971. In addition to its statutory order of reference, the Senate and the House of Commons have, since 1980, renewed an order of reference at the beginning of each session authorizing the joint committee to study the means by which Parliament can better oversee and control the government regulatory process. Taken together, the statutory and sessional references of the committee provide it with broad jurisdiction to inquire into and report on most aspects of the federal regulatory process.
