

## **MINUTES OF PROCEEDINGS**

OTTAWA, Tuesday, June 18, 2024 (110)

[English]

The Standing Senate Committee on Legal and Constitutional Affairs met this day at 3:30 p.m., in room B45, Senate of Canada Building, the chair, the Honourable Mobina S. B. Jaffer, presiding.

Pursuant to the order of reference adopted by the Senate on Tuesday, March 19, 2024, the committee continued its consideration of Bill S-15, An Act to amend the Criminal Code and the Wild Animal and Plant Protection and Regulation of International and Interprovincial Trade Act.

The Honourable Senator Cotter moved that Bill S-15 be amended in the preamble, on page 1,

(a) by replacing lines 4 to 7 with the following:

"Whereas Parliament is of the view that certain animals should not be kept in captivity because of the risk of animal cruelty and the risk to public safety that such captivity presents;";

(b) by replacing line 9 with the following:

"these animals in captivity may be justified in certain cir-".
