

## SCCC role in the NSHS

- SCCC mandate going back to 1987 has been to advocate for soil health and conservation.
- We remain well positioned to bring soil health and conservation stakeholders together
- The Ag Industry will collectively do most of the work on keeping our soil healthy, so it just makes sense that leadership comes from our industry. The NSHS will provide direction for that response.
- SCCC is prepared to provide initial leadership in bringing soil stakeholders together in a collaborative process to build an industry strategy to lead action on soil health in Canada.

## The NSHS defined

### The NSHS will be an <u>industry-led</u> framework and plan for collective action to maintain and enhance the soils in Canada, with an immediate view (by 2030) and longer term (by 2050)

- Collaborative process for setting objectives, goals and priority actions for the agrifood industry
- Fostering agri-food industry's long-term commitments to meeting soil health needs
- Maintaining stakeholder engagement ongoing renewal of NSHS

## Phase 1 Planning and Engagement

- SCCC has convened a group of 22 potential stakeholders that are prepared to lead and invest in moving a national plan forward.
- Tasked with developing broader consensus on the scope of a NSHS that meets the needs of stakeholders across Canada.
  - Make a clear case for the NSHS
  - Create a funding and support framework
  - Engage and influence agri-business decision makers and senior government.
  - Develop an approach for the Phase 2 implementation of the NSHS.


(6-8 months with a budget of \$100 K)

In Phase 2 there will be broader stakeholder engagement to seek additional contributions and consensus on the NSHS implementation.

## Proposed Engagement Material

#### 1. Science-Based Soil Health Actions (Research)

The NSHS will focus on improving our understanding of the production, environmental, and economic impacts of soil degradation and methods to stop, reverse or avoid such impacts in the future.

#### 2. Learning, Education and Technology Transfer (Extension)

The NSHS will focus on initiatives and partnerships that create information and distribution networks for soil health and conservation knowledge.

#### 3. Supporting Public and Private Interests in Soil Health (Resources)

#### 4. Public Engagement (Communications)


The NSHS will focus on engaging more Canadians on the importance of soil health and conservation and to make a personal contribution.

- June 8 Meeting 3 of NSHS Working Group -consensus on phase 1
