5. Senator Gignac requested the resulting budgetary impact and the financial implications in terms of the elements of the Bill S-14

With regard to Akami-Uapishk^U-KakKasuak-Mealy Mountains National Park Reserve, Parks Canada received a total funding of \$69.4 million over 19 years (starting in 2014-15 until 2032-33) and \$4.2 million ongoing. This funding is for:

- the capital development and interim operations the National Park Reserve,
- the implementation of the Labrador Innu Park Impacts and Benefits Agreement (PIBA) in accordance with the terms of the Labrador Innu Incremental Treaty Agreement (ITA) and for the cooperative management of the National Park Reserve.

As for the Tallurutiup Imanga National Marine Conservation Area, Parks Canada received a total funding of \$175.9 million over 12 years (starting in 2018-19 until 2029-30) and \$10.7 million ongoing. This funding is for:

- the establishment, development, and operations of the National Marine Conservation Area.
- the development of interim management plan and pre-implementation activities (such as Guardians pilot program) associated with the National Marine Conservation Area, including capacity funding to the Qikiqtani Inuit Association.
- the negotiations and the implementation of the Inuit Impact and Benefit Agreement with the Qikiqtani Inuit Association, and related infrastructure agreements towards the establishment of the National Marine Conservation Area.
