




## Victims of violent crime, by type of weapon, Canada, 2010

## Victims of violent crime by selected offence and type of weapon, Canada, 2010


percentage of total victims

### Victims of homicide, by cause of death, Canada, 1980 to 2010


rate per 100,000 population

## Victims of homicide committed with a firearm, Canada, by type of firearm, 1980 to 2010


rate per 100,000 population

## **Registration of recovered firearms used to commit homicide, Canada, 2005 to 2010**

percentage of recovered firearms that were registered




**Note:** Based upon the number of homicides committed with a firearm that was recovered by police. Between 2005 and 2010, police reported that 36% of firearms used to commit homicide were recovered. Of these, 34% were owned by the accused person, 5% by the victim and 28% by another person. The ownership of the remaining 32% was unknown.

## Victims of homicide, by motive and type of weapon, Canada, 2000 to 2010


percentage of homicides

### Victims of robbery, by type of weapon, Canada, 1980 to 2010



### Firearm-related offences, Canada, 2000 to 2010


rate per 100,000 population


### Persons accused of violent crime committed with a firearm, by age, Canada, 2010
