AFFIDAVIT OF JANE DOE (

- I, of the City of Toronto, in the Province of Ontario, SOLEMNLY AFFIRM as follows:
- 1. I am the convener of the intervener Feminist Coalition and as such I have direct knowledge of the matters to which I hereinafter depose. Where I do not have direct

knowledge of the facts I have stated the source of my information and I believe such facts to be true.

- I am an activist, teacher, and author focusing on issues of Violence Against Women ("VAW"). In the 1990s, I was the successful plaintiff "Jane Doe" in the landmark case of *Jane Doe v. Metropolitan Toronto (Municipality) Commissioners of Police* (1998), 160 D.L.R. (4th) 697 (Ont. S.C.J.). In that case, the court held that my *Charter* rights to security of the person and equality were violated by the failure of the Toronto Police to warn women in my community about the activities of the "balcony rapist". The court found that the shortcomings of the police investigation were informed by sexist "rape myths" and stereotypes about women.
- 3. For the past three decades, I have been active in education, research, training and policy design respecting VAW issues for a wide range of institutions including multiple universities, the Toronto Police Services Board, the Ontario Court of Justice, the United Way of Toronto, and Humber College. My published work is on the curricula of numerous universities in Canada and internationally. As a result of my work, I have received many awards including honorary doctorates in law from the University of Ottawa and Concordia University.
- 4. My *curriculum vitae* is attached as Exhibit "A" to this affidavit.
- 5. In keeping with the court-ordered publication ban placed on the use of my real name and/or likeness in 1987, and renewed in 1997, I will hereafter use the pseudonym "Jane Doe" for the purposes of my involvement in this appeal and related public dissemination.

Overview of the Feminist Coalition

6. The Feminist Coalition consists of 23 member organizations related to the VAW and feminist communities who share a pro-decriminalization equality outlook on sex work.

- 7. The members of the Feminist Coalition argue in support of both the complete decriminalization of prostitution and full human and labour rights for sex workers. Our membership is national and supported by international organizations including the Global Alliance Against Traffic in Women (GAATW) and the Association of Women in Development (AWID). Our individual mandates and mission statements are specific to the equality rights of all women, including transgendered women, with a focus on providing direct services to those who experience sexualized and gendered violence particularly sexual assault and/or woman abuse. Based on our common experiences and perspectives, we advocate for the decriminalization of prostitution, from an explicitly feminist equality-oriented perspective, in the context of this appeal.
- 8. Each of our member organizations hold specialized knowledge, experience, and expertise in support of our position, enabling us to make a useful and knowledgeable contribution in this appeal. Most significant is our combined decades worth of research, training, and advocacy experience, not represented in the host of interveners that made submissions before the Court of Appeal. Our coalescence into a single coalition will serve to make better use of the Court's time and resources.

Contrast with the Women's Coalition

- 9. There are several similarities and points of agreement between our Feminist Coalition and the Women's Coalition, which intervened in the Court of Appeal. Notably, we:
 - Agree that sex-working women must not be criminalized;
 - Recognize the historical and racialized/colonized specificity of sex work in Aboriginal communities;
 - Agree that sex-working women experience a disproportionate amount of violence, especially those who are street-based.

- 10. Based on our collective knowledge and expertise regarding the issues represented in *Bedford*, however, the Feminist Coalition differs from the Women's Coalition in several significant ways. For example, we:
 - Categorically disagree with the nature of prostitution as outlined in their Court of Appeal factum;
 - Work distinctly and specifically on issues of violence against women and women's equality rights;
 - Work in collaboration with and/or support sex worker run agencies across Canada and internationally, and respect their rights to self-autonomy.
- 11. Additionally, we hold oppositional positions, research, knowledge, and expertise on the following issues as delineated in the Women's Coalition intervener factum:
 - Asymmetrical criminalization of prostitution as applied in the "Swedish" or "Nordic" model;
 - The definition, nature, and role of clients;
 - The definition, nature, and role of so-called "pimps";
 - The conflation of "trafficking" with sex work;
 - The conflation of youth and children with adult women, cis and transgendered, and male sex workers.
- 12. It is our opinion that, as with other groups of marginalized women, the right to autonomy for sex-working women is critical to determine their equality rights under law. We understand that issues including race, colonization, ability, gender identity, sexual orientation, immigration, and class, impact and intersect individually on sex working women and their political organizations.

Feminist Coalition Membership
